## ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

### SUMMARY

#### Offer Price and Net Proceeds

- The Offer Price has been determined at HK\$1.31 per Offer Share (exclusive of brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$1.31 per Offer Share, the net proceeds from the issue of the Offer Shares under the Share Offer to be received by the Company, after deducting the underwriting commission and other estimated expenses payable by the Company in connection with the Share Offer, are estimated to be approximately RMB79.3 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future Plans and Use of Proceeds” in the Prospectus.

#### Public Offer

- The Public Offer Shares initially offered under the Public Offer have been moderately over-subscribed. A total of 2,978 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms, through **HK eIPO White Form** and by giving **electronic application instructions** to HKSCC via CCASS for a total of 102,442,000 Public Offer Shares, representing approximately 11.4 times of the total number of 8,984,000 Public Offer Shares initially available for subscription under the Public Offer.
- In addition to the 8,984,000 Public Offer Shares initially available for subscription under the Public Offer, a total number of 18,000,000 Offer Shares have been reallocated to the Public Offer from the Placing, so that the total number of Offer Shares allocated to the Public Offer has been increased to 26,984,000 Offer Shares, representing approximately 30.0% of the total number of Offer Shares initially available under the Share Offer.

## Placing

- The Placing Shares initially offered under the Placing have been slightly over-subscribed. The final number of Placing Shares allocated to 79 placees under the Placing is 62,856,000 Offer Shares after reallocation to the Public Offer, representing approximately 70.0% of the total number of the Offer Shares initially available under the Share Offer. A total of 39 placees have been allotted five board lots of H Shares or below, representing approximately 49.4% of the total number of placees under the Placing. These placees have been allotted approximately 0.2% of the 62,856,000 Offer Shares (after reallocation) available under the Placing. A total of 28 placees have been allotted one board lot of H Shares, representing approximately 35.4% of the total number of placees under the Placing. These placees have been allotted approximately 0.1% of the 62,856,000 Offer Shares (after reallocation) available under the Placing.
- The Directors confirm that, to the best of their knowledge, information and belief, all placees under the Placing and their ultimate beneficial owners are independent of and not connected with the Company and any of the Directors, chief executive, Controlling Shareholders, substantial shareholders or significant shareholders (as defined under the GEM Listing Rules) of the Company or any of its subsidiaries or their respective close associates (as defined in the GEM Listing Rules), and are not any person or group of persons as stated in Rule 10.12(4) of the GEM Listing Rules or any nominees of the foregoing, and none of the Placing Shares subscribed by the placees has been financed directly or indirectly by any of the Directors, chief executive, Controlling Shareholders, substantial shareholders or significant shareholders of the Company or any of its subsidiaries or their respective close associates, and none of the placees is accustomed to taking instructions from any of the Directors, chief executive, Controlling Shareholders, substantial shareholders or significant shareholders of the Company or any of its subsidiaries or their respective close associates in relation to the acquisition, disposal, voting or other disposition of Shares registered in his/her/its name or otherwise held by him/her/it.
