Any vote which is not filled or filled wrongly or with unrecognisable writing or not cast will be counted as "ABSTAINED". Failure to complete the boxes will entitle your voting proxy to cast his vote at his discretion. A holder of H Shares is entitled to one vote for every fully-paid H Share held and a holder of H Shares entitled to more than one vote need not use all his votes in the same way. A tick in the relevant box indicates that the votes attached to all the H Shares stated above as held by you will be cast accordingly. The total number of H Shares referred to in the three boxes for the same resolution cannot exceed the number of H Shares stated above as held by you. Unless you have indicated otherwise in this form of proxy, your proxy will also be entitled to vote at his discretion on any resolution properly put to the H Shareholders Class Meeting other than those referred to in the notice of the H Shareholders Class Meeting.
- This form of proxy must be signed by you or your attorney duly authorised in writing or, in the case of a legal person, must either be executed under seal or under the hand of a director or an attorney duly authorised to sign the same. If this form of proxy is signed by your attorney, the power of attorney authorising that attorney to sign, or other document of authorisation, must be notarised.
- Where there are joint holders of any H Shares, any one of such persons may vote at the meeting, either personally or by proxy, in respect of such H Shares as if he/she was solely entitled thereto. However, if more than one of such joint holders is present at the H Shareholders Class Meeting, either personally or by proxy, then one of the said persons so present whose name stands first in the register of members in respect of such H Shares shall alone be entitled to vote in respect thereof.
- In order to be valid, for holders of H Shares, this form of proxy, together with the notarised power of attorney or other document of authorisation (if any), must be delivered to the H Share registrar of the Company in Hong Kong, Tricor Investor Services Limited, at Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong not less than 24 hours before the time appointed for the H Shareholders Class Meeting or any adjournment thereof (as the case may be), i.e., before 11:00 a.m. on Sunday, 17 May 2020.
- Completion and delivery of a form of proxy will not preclude you from attending and/or voting at the H Shareholders Class Meeting or any adjournment thereof (as the case may be) if you so wish.
- To attend and represent holder(s) of the H Share(s) at the meeting, the proxy so appointed must produce beforehand his identification document and any power of attorney duly signed by his appointor(s) or the legal representative(s) of his appointor(s). The power of attorney must state the date of issuance.
